**SECTION 1 ~ THE PARTIES**

**1. Parties to this Agreement**

**SECTION 2 ~ NATURE OF AGREEMENT**

**2. Purpose & Scope**

This Agreement establishes the terms of a 3-month probationary partnership during which the Guide will offer services on the ONEE platform under Synchronee City Wellness Technologies Corp.

Synchronee City Wellness Technologies Corp. operates strictly as a technology intermediary. The Company does not practice, diagnose, treat, or provide any form of health, wellness, psychological, or spiritual services directly.

This Agreement does not create an employer-employee relationship, agency, or partnership beyond the scope of platform participation.

**SECTION 3 ~ TRIAL PERIOD**

**3. Probationary Period**

During the probationary period:

- The Guide's profile will be listed and active on ONEE.
- Seekers may book the Guide's services through the platform.
- Revenue sharing will apply as specified in Section 4.
- Either party may conclude the trial with written notice before or at the end of Month 3.
- A review conversation will be initiated in the final two weeks of Month 3.

*The probationary period is a co-creation phase. Continuation is mutual ~ not assumed.*

**SECTION 4 ~ REVENUE MODEL**

**4. Revenue Sharing**

The Guide selects one path at signing. The selected path applies for the full probationary period.

**PATH A ~ COMMISSION MODEL**

**15%** of each completed booking retained by the Platform, inclusive of payment gateway fees. No monthly fee applies. The fair entry way ~ full platform access, full promotional support, zero upfront cost. *Upgrade to Path B as bookings grow.*

**PATH B ~ SUBSCRIPTION MODEL**

Monthly fee of **Philippine Pesos 1,999 (■1,999/mo)** plus **5%** per completed booking. Guide retains 95% of gross booking value less the monthly subscription. This path exists as a clear progression ~ as bookings grow, it becomes the route to keeping more of what you earn. *Available when the Guide is ready to move.*

Payments are processed within seven (7) business days of booking completion. The Platform reserves the right to withhold payment pending resolution of disputed or refunded bookings.

## SECTION 5 ~ GUIDE RESPONSIBILITIES

---

### 5. Guide Obligations

During the probationary period, the Guide agrees to:

- Maintain an accurate, current profile including availability, modality, rates, and service descriptions.
- Honor all confirmed bookings. Cancellations require a minimum twenty-four (24) hour notice to the Seeker.
- Communicate with Seekers in a manner aligned with the values of Synchronee City ~ respectful, boundaried, and professional.
- Refrain from redirecting Seekers to external booking channels for services listed on ONEE during the probationary period.
- Disclose any material changes to practice, credentials, or availability affecting the platform listing.
- Represent credentials accurately. The Platform does not certify or endorse the qualifications of any Guide.
- Cooperate reasonably with promotional activities as described in Sections 6.1 and 6.2 ~ including submission of raw video content, bio, corporate profile photo, and CV or credentials as requested, and timely review of proposed materials.

## SECTION 6 ~ PLATFORM RESPONSIBILITIES

---

### 6. Platform Obligations

Synchronee City Wellness Technologies Corp. agrees to:

- Provide an active profile listing on ONEE for the full probationary period.
- Process booking payments per the selected revenue model within the standard payment window.
- Provide reasonable technical support within three (3) business days of notification.
- Notify the Guide of platform policy updates with reasonable advance notice.
- Conduct a review conversation in Month 3 to discuss renewal, continuation, or conclusion.

#### 6.1 Promotional Support

Promotional support applies to all Guides regardless of revenue path selected. Subject to Guide consent per format, Synchronee City Wellness Technologies Corp. will:

- Post promotional content about the Guide's offerings across ONEE's official social media channels.
- Notify Seekers of the Guide's availability through in-app notifications and newsletters.
- Produce and edit all promotional materials at the Platform's expense.
- Respect the Guide's preferred promotional format and agreed extent of involvement.

#### 6.2 Cross-Promotion & Welcome Integration

As part of welcoming each Guide into the ONEE ecosystem, the following cross-promotional outputs will be produced. All editing, processing, and publishing are handled exclusively by Synchronee City Wellness

Technologies Corp. The Guide will review all outputs before publication.

**Guide Responsibilities ~ Content Submission.** To enable production, the Guide agrees to provide the following to Synchroness City Wellness Technologies Corp. prior to or during the onboarding period:

- **Raw video content (minimum 1 minute).** Filmed by the Guide in any setting that reflects the authenticity of their message ~ their practice space, home, or any environment that conveys who they are. No professional production required. The Guide provides the raw footage; Synchroness City handles all editing.
- **Bio and About section.** A written summary of the Guide's background, practice, intention, and the Seekers they serve ~ for use in their ONEE profile and promotional materials.
- **Corporate profile photo.** A clear, professional photograph of the Guide suitable for use on ONEE's social media channels and platform profile.
- **Curriculum Vitae or credentials (if applicable).** A copy of relevant certifications, training, or professional background ~ for internal verification and profile enrichment. Not published without Guide consent.

**Platform Responsibilities ~ Production & Distribution.** Upon receipt of the above, Synchroness City Wellness Technologies Corp. will produce and distribute the following, at no cost to the Guide:

- **Welcome Post.** A dedicated post introducing the Guide as a member of the ONEE Guide ecosystem, published across ONEE's official social media channels.
- **One-Minute Introduction (International Guides).** For Guides based outside the Philippines ~ a Synchroness City-branded welcome video featuring the Guide's own introduction, edited from submitted raw footage, so Seekers can watch and connect before booking.
- **Service Demo Feature (Metro Manila / On-Site Guides).** For Guides based in or able to access Metro Manila ~ a short-form demonstration or showcase of the Guide's core offering, produced and filmed on-site by Synchroness City Wellness Technologies Corp.
- **Interview Feature.** A short-form editorial interview ~ written or video format ~ highlighting the Guide's practice, philosophy, and offering. Published on ONEE channels and distributed to Seekers.

All outputs produced under Section 6.2 are edited and published by Synchroness City Wellness Technologies Corp. The Guide retains the right to review and request reasonable amendments before publication. Final editorial and distribution decisions rest with the Platform.

*Cross-promotional outputs are a platform commitment ~ not a guarantee of booking volume or minimum revenue outcome.*

### 6.3 Glimmer Vault & Voluntary Access Offerings

Guides are encouraged ~ though never required ~ to participate in two voluntary access initiatives as part of ONEE's commitment to inclusive wellness:

- **Glimmer Vault.** Guides may offer selected content or recorded sessions on a pay-what-resonates basis through the Glimmer Vault feature. This is the Guide's intentional offering to the collective ~ a voluntary act, not a platform obligation.
- **Free Introductory Webinars.** Guides may host free, open-access webinars through ONEE for Seekers who wish to experience their practice before booking. This serves as an inclusive entry point and extends the Guide's reach to Seekers who are exploring. Scheduling, promotion, and platform support are provided by

## SECTION 7 ~ CONFIDENTIALITY

### 7. Confidentiality

By signing this Agreement, the Guide acknowledges that platform architecture, business model, revenue structure, onboarding process, community framework, and related materials are proprietary and confidential.

The Guide agrees not to disclose or share any confidential information without prior written consent from Synchronee City Wellness Technologies Corp.

This confidentiality obligation survives termination or expiry for two (2) years.

## SECTION 8 ~ INTELLECTUAL PROPERTY

---

### 8. Intellectual Property

The Guide retains full ownership of their practice, methodology, content, and intellectual property.

By listing on ONEE, the Guide grants Synchronee City Wellness Technologies Corp. a non-exclusive, revocable license to display and promote the Guide's profile and agreed content for the duration of this Agreement.

Where the Guide consents to promotional content production (Section 6.1), a separate written consent form will specify format, usage, and duration.

The Platform retains full ownership of its technology, brand, platform architecture, and the ONEE ecosystem ~ including all associated trademarks and intellectual property of Synchronee City Wellness Technologies Corp.

## SECTION 9 ~ TERMINATION

---

### 9. Termination

Either party may terminate this Agreement before Month 3 with fourteen (14) days' written notice.

The Platform reserves the right to immediately suspend or terminate Guide access without notice in cases of:

- Material breach of any provision of this Agreement.
- Conduct that violates ONEE community standards or brings harm to Seekers.
- Fraudulent, misrepresentative, or deceptive activity.

Pending payments for completed bookings will be processed within the standard window. No partial-month subscription refund will be issued.

## SECTION 10 ~ GENERAL PROVISIONS

---

### 10. General

**Governing Law.** This Agreement is governed by the laws of the Republic of the Philippines.

**Entire Agreement.** This Agreement constitutes the full understanding between the parties and supersedes all prior discussions.

**Severability.** If any provision is found invalid, the remaining provisions remain in full effect.

**Notices.** All formal notices shall be sent to the contact information provided in Section 1.
